The third game, when necessary, will be a 15 point game with each team switching sides at 8 points.

After completion of the first round, all first place finishers from each A.M. pool (8 total) will advance to Sunday's 16 team bracket playoffs and hold seeds. The remaining 16 teams will be placed into four pools of four teams and will play their second round of pool play Saturday commencing at 3:00P.M. The first and second place finishers in the second round pool play will fill the $9-16$ seeds. Teams that place third or fourth in Saturday's P.M. pool will be released to go home. Only the top 16 teams will move on to Sunday's playoffs. Sunday will consist of a single elimination 16 -team bracket tournament based on the following criteria.

Within a Pool:
When two teams are tied, the outcome of the match between the two teams will decide their position within the pool. When three teams in the are pool have the same match record the following criteria will be used:

A: Game winning \%
B: Point differential
C: Coin toss

A: Match record (applicable only if all teams in the tournament compete in the same number of matches)
B: Game winning \%
C: Point differential
D: Coin Toss
