# **OVR Poised for Spectacular 2005 Season**

The Ohio Valley Region is on track to break last season's records for registration, Championships tournaments, and Bid qualifiers.

The OVR directors and officers, as part of their constant effort to improve the quality of play and to expand playing opportunities in the Ohio Valley Region, effected a number of changes for the 2004-2005 season. A few of the most important include:

- grade-level Club play within the OVR
- adults' teams must provide a certified official for pool play
- addition of two new officials' clinics, along with new clinic formats
- identical uniforms for adults' teams
- Women's Open players can now play down to A
- refinement of the Junior Officials' Development Program
- background screening
- use of fivb rules, as presented by USAV

Some changes were made in direct response to members' requests and suggestions; others were made proactively to promote and sustain quality volleyball. In addition, consistent with USA volleyball, we will use FIVB rules, as presented by USAV. Background screening (www.ovr.org/register/background\_screening.php) will be required for all individuals who will interact with juniors in sanctioned activities, including professional officials.

These new rules and policies, as well as others, are detailed throughout this issue of OVR The Block and on the OVR website. Please take some time to read the columns by Ron Wyzynski, Bob Price, Bill Zehler, Brian Hemelgarn, Tom Kohl, Nick Nystrom, Michelle Fox, and other contributors, and watch the OVR website for additional news. And most importantly, enjoy the best season yet in the Ohio Valley Region!

## **OVR Elections 2005**

Each year the OVR elects 5 candidates to the board of directors to serve a term of three years, non-compensatory. Candidates must be OVR members and acquire 25 signatures of currently registered adult members. In addition, aspiring board members should submit a profile stating the reasons they want

to serve on the board of directors, how they feel they can help the region, and their relevant backgrounds. The submission deadline is March 31, 2005. Board terms ending on May 31, 2005 include those of Bob Dickerson, Art Fai

those of Bob Dickenson, Art Faura, Terry Miller, Glenn Purdy, and Bill Zehler.

Those wishing to run for election for the OVR board of directors should submit all candidate materials to Elaine Viney, 2005 OVR Elections Chairperson (viney@ovr.org; Elaine Viney, 857 Creighton Ave., Dayton, OH 45410-2920). The petitions and profile are available on the OVR website (www.ovr.org/elections/).

To assist voters in their selections, background information for all candidates will be published at www.ovr.org/elections/, posted on the bulletin board at the Convention Center at OVR Championship tournaments, and made available at the satellite sites. Online profiles will on April 1 or soon thereafter.

Voting will held at the 2005 Ohio Valley Regional Volleyball Championships on April 16-17 and at the Ohio Valley Region, Inc.—Kaepa<sup>®</sup> USA 2005 Girls' Volleyball Championships on May 7,

14-15, and 20-22. For those adult members unable to be present at our Championships, a mail-in ballot will be available. Mail-in ballots must be postmarked by May 23, 2005.

Officer terms ending on August 31, 2005 include Commissioner, Men's Tournament Director, Regional Scorekeepers' Chair, and Juniors' Tournament Director. These positions are elected by the board of directors.

# **Executive Director's Commentary**

#### Dear members.

I'd like to dedicate the first part of my article to Bob Dickenson, an OVR board member who recently passed away on November 27<sup>th</sup> after a long illness. Bob was a player, a coach, and an official in the OVR for many seasons. As an elected board member, he



attended the meetings even during his illness. He performed many duties behind the scenes during this time. Bob's thoughts were always of doing the things necessary for the membership. I'm sure he'll be missed by his many close friends.

#### Working Together for 2005

Now that the start of the season is fast approaching, a few reminders... Paperwork... Team Representatives, Juniors' Directors, Officials, and any other adults involved in directing or coaching a team/club must real-

ize that certain paperwork must be turned in to the region. An example would be background screening release forms, coaches' code of ethics and waivers for juniors' directors, coaches, officials, and junior players. Adult players should all sign a waiver before participating. You can make a copy from the website. Juniors' coaches should have the medical release information with them, which they can get from their director for both practice and tournaments. If we all work together and get this done before the start of the season, early January for adults and late January for juniors, we can put this task behind us. As good as the website is, it can't do the work that you need to do, so please do your part.

The region office issues individual and group rulebooks as soon as registrations appear on my screen. Every adult player, coach, official, and director should receive a book by mail unless other arrangements have been made. Last season, many coaches told me they never received a book... that will not be the case this season.

#### Clinics and Courses

On November 28<sup>th</sup>, the first 2 of 10 officials' clinics took place. Brian Hemelgarn informed me that 87 attended the clinic in Toledo, about half of whom were new individuals. On December 4<sup>th</sup> in Westerville, approximately 135 individuals signed up for the new officials' clinic on Saturday. We welcome these individuals to the OVR. Also on this same day, the new juniors' club directors participated in ASEP training, hosted by Bill Zehler, and over 100 juniors' coaches participated in IMPACT instruction, taught by Don Burroughs.

It all comes down to another excellent beginning for the OVR. As with any large organization, we don't work for each other, we work with each other. Have a successful season whatever your volleyball related interest.

# Bill Zehler, OVR Juniors' Program Director

ELCOME TO THE OHIO VALLEY REGION JUNIORS' PAGES.

Juniors' volleyball programs are going strong across the region. Over 900 tournaments are already scheduled. The OVR Power Tournaments and Power Challenge events are filling fast. Clubs are busy filling their teams' tournament schedules.

#### Coaches' Certifications

Coaches are reminded that they must be IMPACT or CAP accredited to coach for a USA volleyball program in the OVR. *Every* coach must have one of these certifications. Completed *Juniors' Coaches' Code of Ethics* forms must be submitted by every club for each of its coaches. Each coach must have a background check completed through SSCI, the screenaging agency contracted by USA volleyball. All clubs must be in compliance with this regulation.

#### OVR-Kaepa® USA Girls' Volleyball Championships

We will begin accepting registrations for the *Ohio Valley Region, Inc.-Kaepa® usa 2005 Girls' Volleyball Championships* on February 1, 2005. The deadline for entry will be April 1, 2005. Clubs will enter knowing that there will be a financial penalty for withdrawing from the event. Teams entered before the deadline, with checks submitted in a timely manner, will be accepted based on their regional ranking. Teams that enter after the deadline will be accepted only if there are openings. Remember that all registration is done online, unlike local events!

Our Girls' Championships will again be held over 3 weekends this season. We will be using schools in and around Columbus, Ohio on Saturday, May 7, for the 10-and-under and 12-and-under divisions.

The Greater Columbus Convention Center will be the site for the next two weekends (see the Juniors' Tournament Schedule). We will use 40 Sport Courts each weekend at the convention center.

Once again, teams entering this event, then with-

drawing, will receive a partial refund (\$25 penalty) if they are replaced up to two weeks before their event. There is no refund if a team withdraws from the tournament within two weeks of its scheduled event. We will use seeding points accrued and reported up to the posting of the pools. We will try to accept every team that registers for this event. We reserve the right to move teams to the Open or Club divisions, or up in age group for this event. The skill level of our top Club teams and our lower Open divisions are very comparable.



#### Coed 10-and-Under Division

One new concept we are trying to develop this season is to permit boys to participate in our 10-and-Under division. Boys may participate on girls' teams or form their own team and play in 10-and-Under events (the registration fee for 10-and-Under is \$50/member). We encourage all of our clubs to start 10s' teams, regardless of the gender. Permitting boys to be a member of these teams can only increase the number of teams in the division, and it helps start boys' volleyball teams!

# **Juniors' Tournaments 2005**

The 2005 version of the procedures and rules for juniors' regular-season

TOURNAMENTS applies to both girls' and boys' tournaments. Many changes were made to this document to update current rules and to clarify minor abuses that were reported last year. In addition, the formats

for the 10-team and 14-team pool play were updated.

#### **Guidance for Club Directors**

With the cooperation of many people, the 2005 Procedures and Rules for OVR Juniors' Club Directors is now available. This document was a request from the Club Directors' Forum held in December, 2003.

#### Priorities for 2005

I have six concerns for this up-coming season:

- 1. Ensure quality of tournament facilities and play.
- 2. Prompt and thorough online reporting of tournament results.
- 3. Power Challenge and Bid Qualifier organization.
- 4. Expand support documents for boys' volleyball.
- 5. Greater use of the OVR website by club directors to update their teams' information.
- 6. Develop increased interest and participation in boys' volleyball.

#### **Application for Sanction**

Thank you to those tournament directors that have completed the online process for their Applications for Sanctions for the 2004-2005 season. As of March 13, 2005, we have 996 sanctioned tournaments by 106 different tournament directors. If you'd still like to run one or more tournaments, fill out the online Application for Sanction at www.ovr.org/juniors/sanction/ as soon as you know your plans.

Please be advised that all tournament directors must be members of USA volleyball. Online registra-

tion can be completed at www.ovr.org/register/. Contact Ron Wyzynski (1-888-873-9478, wyzynski@ovr. org) or Nick Nystrom (nystrom@ovr.org) for registration information. Any tournament director not having complete the registration process for the 2004-2005 season and having a completed background check will not have their tournament listed on the OVR website. The full OVR-Kaepa® USA 2005 Juniors' Tournament Schedule will be published at www.ovr.org/juniors/tournaments.php at 8AM on December 19.

As I sanction tournaments, I will e-mail copies of the *Procedures and Rules for Juniors' Regular-Season Tournaments* and the *Checklist of Juniors' Tournament Procedures*. Additional forms you need to conduct your tournament can be found in the *Juniors' Tournament Packet* (www.ovr.org/juniors/tournament\_packet/).

It is important for all parties involved in an OVR-sanctioned tournament—tournament directors, officials, and coaches—be informed of tournament procedures and rules to ensure consistency of play and reporting of results. Should you have any suggestions, please e-mail me at kohl@ovr.org.

#### Power Challenge, Boy's Regionals, and Bids

Currently, my emphasis is on the Power Challenge Tournaments, Boys' Regionals and preparing for the Bid Tournaments. The response to the Power Challenge tournaments has again been overwhelming. Teams participating in the six Power Challenge tournaments have increased from 115 teams to 130 teams this year. Many thanks to Art Faura and Brian Hemelgarn for their help in setting up these tournaments.

26 teams, an increase of 6 teams over last year, partipated in the *OVR Boys' Regional Volleyball Championships* on March 5-6. Details and results are printed on page 7, and photos will be printed in a subsequent issue of OVR The Block. Thanks to Mark Bula and Steve Brewer for their help.

Registration for the *Ohio Valley Region-Molten*® 2005 National Bid Qualifier was open from February 1-28. Please be sure to follow through with entry feed and JOVC information and registration. # **IMPACT Coaching Requirement**

# Don Burroughs, OVR Director of Coaching Education & High Performance



IMPACT is an entry-level coaching requirement of both USAV and the Ohio Valley Region. Individuals who wish to coach a club team in the OVR must be IMPACT certified. If an individual is found negligent of certification, that individual must be immediately replaced with a qualified person. Violations of this requirement may include probation, suspension, fine, or whatever disciplinary action is deemed appropriate by the authorized person, persons, boards, or committees of the OVR. All IMPACT clinics will be 4 hours in length. This time frame is necessary to cover all the required information and adequately explain the various topics covered in the course.

Coaches may attend an IMPACT clinic in another region; however, it becomes that coach's responsibility to ensure that a copy of the certificate is forwarded to Don Burroughs so that it may be recognized by the OVR.

Further, the OVR will be offering several opportunities for the next steps of USAV coaching education. CAP I and CAP II clinics will be offered several times in 2005, possibly in May and December. The OVR website is your best resource for up-to-date and current information regarding all coaching education opportunities in our region.

# **Training and Certification for Junior Officials**Barb Strome, OVR Junior Officials' Development Director

Any 17 or 18 year old registered player interested in officiating as a first referee for the 10s and 12s within the OVR should contact me as soon as possible. Training sites for Junior Olympic Officials' certification include Synergy Sports and Fitness

(Toledo, Ohio) on February 5, and Miami University (Oxford, Ohio) on February 26. Last year we had 26 girls go through the training, 23 of whom completed the process. We would like to continue to grow the program.



# From the Referees' Chair

# Brian Hemelgarn, OVR Regional Referees' Chair

HERE WE ARE AGAIN. It's just amazing how quickly time flies! I'm really excited about the upcoming season, the new rules, and the opportunities that lie ahead. We'll have a record number of officials in the OVR this year — not only a record for us, but a record that no other region in the country can

match! We should be proud of our accomplishments and continue to work hard to not only be the biggest region, but also the best!

Now, some notes for this season... We hosted six clinics this year, and over 600 people attended! That includes the more than 300 existing referees on our roster, plus more than 200 prospective new officials, and at least 100 adult team reps. Our modified format seemed more efficient, and the use of our PowerPoint presentation really enhanced our materials. We're already planning our clinics for

next season, and they'll be better yet.

Although we covered the rules and techniques changes as well as OVR guidelines, there will still be plenty of questions this season, so you can look forward to my normal barrage of e-mails! We'll also have information posted on the website, so it's imperative as professional officials that we utilize the resources our website offers.

We need to strive for consistency this year, regardless of experience level or our rating. We need

to dress sharp, look sharp, and be professional. With our pay increase to \$150 per day (for six matches), the few extra bucks in our pocket might be well served for a new pair of slacks, shoes, or referee's shirt.

With 200 referee candidates, there's a good chance we'll all have the opportunity to work with and mentor these new folks. We must help them, share our knowledge, and teach them the correct way do things. Consider being a mentor for one or two of our new folks as they enter their first season as a professional referee.

Speaking of new officials, the possibility of having 200 more OVR referees made me realize I needed some help to better serve everyone. We already have a cadre of 300 referees, and working with 500 will be virtually impossible to do alone. As a result, Tom Joseph has been appointed our New Officials' Coordinator, and has already done a tremendous job with our new folks! Likewise, Patty Salvatore is taking on the task of Testing Administrator so that everyone can receive replies regarding test corrections, rule references, or comments about the test questions themselves. Unless you received 100% on the test, I'm sure you'll be hearing from Patty soon!

I'm looking forward to working with everyone again, and as always, if there is something I can do to better serve as Referees' Chair, please let me know. On behalf of the OVR board of directors, thanks for the great job you'll be doing in 2005!

# **Adults' Tournaments Needed**

WE COULD STILL USE MORE TOURNAMENTS on the schedule for many divisions in some locations. If anyone on your team has access to a facility, check and see if it is available for use to run a USAV tournament. It's easy to run a tournament for your team, and depending on the cost of the facility, you may be able to make a small profit. Check out the Men's and Women's Tournament Packet, www.ovr.org/mw/tournament\_packet/, for everything you need to know plus all of the paperwork necessary for running a tournament. If you can get a facility and a tournament date, your OVR Tournament Directors would be happy to add it to the schedule.

Regionals will be held on April 16-17, 2005 at the Greater Columbus Convention Center. Divisions for each day will be posted on the Men's and Women's Tournament Schedule when approximate numbers of teams are known.

NABLING ALL 15,000+ OVR MEMBERS to gain maximum advantage from OVR infrastructure continues as a top priority. Through deep integration of our registration and reporting facilities, web communications, and participation by all members, we strive to bring everyone the information, results, and involvement they need to realize a rewarding and successful season of volleyball in the OVR.

#### Registration

Registration for the 2004-2005 season is progressing at an unprecedented rate, on track for what appears to be another record-breaking year. The OVR registered 15,052 individuals in 2003-2004, and projections place 2004-2005 at over 15,500.

When registering, please note that it is critical to complete your registration promptly. Providing your information through our online registration process is only the first step: you must then follow up by mailing your registration fee, background screening fee (for those working with juniors, including officials), and completed and signed forms to Steve Donahue. Registrations are not complete until Steve Donahue receives and records your fees, forms, and "Clear" background screen. Please note that prompt payment is required because we must forward fees and information to the USA volleyball national office to begin members' benefits and to comply with national requirements.

#### Accounts and Authentication (Signing In)

As I mentioned in the previous issue of OVR The Block, all OVR members (but no non-members) ore eligible for accounts on the OVR website. Accounts are created automatically for all adult members on registration (transferring last season's if possible). If a new account is required, or if details of an existing account are lost, the "Forgot your username or password?" utility on the sign-in lets members regain access immediately using minimal combinations of their username, actual name, registration number, e-mail address. Intervention is required only for cases where account information is lost and the member's e-mail address has changed from that which we have on file. Note that the "Forgot your username or password?" even works when we do not have an e-mail address on file. In that case, an e-mail address may be provided, together with some


additional data to ensure data integrity.

Signing in (also known as logging in or authenticating) is required for changing one's address, e-mail address, or phone numbers, for applying for sanction of juniors' tournaments, for reporting tournament results or junior officials' certifications, for using

OVR e-mail facilities, for entering teams into the *Girls' Champion-ships* or *Bid* tournaments, and similar tasks where it's important to ensure that person performing them is authorized to do so.

#### **Discussion Forums**

The OVR supports two independent discussion forums, one for the OVR community and the other for the national officiating community. Through our forums, it is possible to discuss relevant topics with interested individuals throughout our region at any time, engaging necessary resources and sharing the outcomes with

#### **Boys' Fall League**

#### Registration

Full ssns are required for professional officials. For all others, only the last 4 digits of ssns are now needed.

OVR website accounts are now available only to members.

#### **Background Screening**

The new background screening procedure is working well.

7 NGBs are currently doing background screening. The "Protect Act" being considered by congress is likely to extend background screening to all NGBs.

#### Youngstown State University

With KSU no longer available, Ron secured 4 dates in January (6 courts) and is working on others.

#### Compensation for OVR Officers and Staff

Ron circulated the pay scale for the FY2005. Only 14.385% of the OVR

budget goes to salaries, which is low for a non-profit corporation.

Work such as setting up the Convention Center is distinct, to be paid hourly as independent contractors.

#### Boys' Regional Championships

Tom, tournament director of the OVR Boys' Championships, is seeking a site or sites for the event.

#### **Grade-Level Teams**

Grade-level teams will be allowed to play in regular-season Open tournaments not to include the Power Challenge or Bid tournament.

#### Coed 10-and-Under Teams

Teams may be composed of girls, boys, or both.

Tournaments may be offered without professional officials at a cost of \$75-90 per team.

Tournaments hosted prior to April 1st

may allow coaches to reserve balls to allow rallies, although the point will already have been scored. After April 1<sup>st</sup>, regular rules will come into effect.

Uniform shorts for males and females on the same 10-and-Under team must be identical in color only.

#### Offering of Early Player Contracts

The OVR may constrain activities that will involve OVR membership. The OVR is not required to accept membership for organizations or individuals who do not follow OVR policies.

Club directors may not offer a contract until the first day for tryouts.

#### **IMPACT**

IMPACT instructors must have CAP II + 3 years of coaching experience after CAP II

IMPACT clinics: December 4, 1-4: Westerville; February 19, 9-1: Piqua JHS; Possibly Kent, Lebanon (Cincinnati)

Club-hosted IMPACT clinics are discontinued because they were run poorly and not well attended.

Don suggested cards for IMPACT certification.

The IMPACT manual is down to 60 pages, with the rest replaced by online resources.

#### **CAP**

Our next large CAP clinic will be late spring.

We must start offering more clinics, including 1-day clinics where people can meet their module requirements.

#### Ron Wyzynski — OVR CEO/ Executive Director

Ron provided a brief synopsis of 2005 membership numbers and status of the registration process.

The Ovr's contract with Molten® will continue to provide valuable cost savings.

At the Jan. 15 YSU tournament, none of the teams present (14 Men's A, 4 Women's Open) had significant complaints about the player officials for pool play, and teams felt the pace of the officiating during ratings was much slower than if players had officiated. This is inconsistent with complaints Bob and Al heard during 2004 at many tournaments; Ron will poll teams next weekend to determine their preferences.

By April 16, 2005, an adult team's players must have identical uniforms (jerseys and uniform bottoms). Team whose players are not in identical uniforms, per Rule 4.3.1 and USAV 4.3.4 of the 2004-2005 Rulebook, shall not be permitted to participate in the OVR Adult Regional Championships.

#### Bob Price — OVR Commisioner/ President

The region purchased an 18' trailer to store and transport the equipment needed for our large events.

Bob discussed various problems dealing with club tryouts,

Bob presented possible facilities for future tournaments.

Bob presented Nick's report to the Board (sent via e-mail to Board members)

#### Juniors' Issues

Barb reported that as of the Kent clinic last weekend, she had certified 60 juniors' clinicians.

The Form D test for juniors is online.

Currently, 915 junior tournaments have been sanctioned.

Tom Kohl was congratulated for the tremendous work he's doing with the boys' program.

The OVR's investment in the Charleston tournament, which is now being organized by the local club, was worthwhile.

# Don Burroughs — Director of High Performance and Coaching Ed.

USAV is likely to redefine the CAP certification levels. As part of this revision, USAV may require juniors' teams that participate in the National events to have at least one CAP I certified coach. The OVR training and certification program is putting us on good footing to meet this future requirement.

Don suggested laminated business cards or plastic cards, which coaches must show at each tournament (plus government-issued photo ID) to prove their compliance. Coaches may be required to wear the card on a lanyard during tournaments.

Don bought two LCD projectors for OVR use and will purchase two more projectors (increasing the total to 5).

# Brian Hemelgarn — OVR Regional Referees' Chair

610 individuals attended our officiating clinics, including approximately 300 existing officials, 210 new officials (even with the \$70 clinic fee), and 100 adult players.

Existing officials include 38% women and 62% men.

Tom Joseph will assist Brian as the New Officials' Coordinator, factoring in candidates' volleyball background and experience to group individuals during the evaluation process.

Brian received useful (mostly positive) feedback about the clinic format and revised rating/evaluation process.

Brian discussed contrasting jersey color for Liberos, clarifying that a contrasting vest over the uniform jersey is not authorized for the libero unless the player is a redesignated Libero due to injury.

Out-of-region officials must pass background screening before working in the OVR.

#### **Regional Championships**

Prizes were discussed, with emphasis on a design commemorating the event.

For April 8-10 (Bid weekend), officials will be housed at the Marriott on I-680 due to the Frozen Four event having booked all downtown rooms.
